

#### **Ascension Lutheran Church History**

On January 6, 1960, Rev. Maynard G. Halvorson was called to lead a new Lutheran Church being established in Ogden, Utah. On September 18, 1960, the congregation was formally incorporated. The first worship service of the new Ascension Lutheran Church was held in the Horace Mann School Auditorium located at 1300 9<sup>th</sup> St., Ogden, UT. There were 70 people present at that service.

December 1960 was a busy month for the new church. On December 4<sup>th</sup> the first group of charter members was received. There were 99 people in attendance at this service. On Christmas Day, Ascension Lutheran Church had its first Baptism Ceremony. There were eleven (11) received in baptism that day.

On Sunday January 29, 1961, at 12:15 p.m. the Groundbreaking Ceremony for the new Ascension Lutheran Church Building was held. Construction on the church building was started on February 1, 1961. Builders Inc. of Ogden led by Charles Peterson, SLC Architect, was responsible for designing and building the new church.

On December 17, 1961, the first Adult Confirmation class was completed and seven (7) were confirmed. Later, May 27, 1962, the first Youth Confirmation class was completed and seven (7) were confirmed.

The Farewell Service for Pastor Halvorson and his family was held on March 22, 1964. Ascension Lutheran Church called Rev. William Jeffs of Phoenix, AZ, to be the second pastor and he was installed on June 1, 1964. Pastor Jeffs left Ascension a little over a year later to assume duties elsewhere on August 22, 1965.

On August 10, 1965, Rev. Robert Berndt was called to be the third pastor. He was installed on October 17, 1965. He gave his farewell sermon on April 20, 1969, and then left to assume duties in Badger, SD.

On March 22, 1969, Rev. Glenn Pedder from Dubuque, IA, accepted the call to Ascension Lutheran Church. He began his ministry in Ogden on June 15, 1969. It was under his leadership that the institution of the Bethel Series Bible Study Program was approved in a congregational meeting. Pastor Pedder left Ascension to become a Chaplain in the U.S. Army on June 25, 1972.

In August of 1972, Rev. E Paul Hoefer began his service as Ascension's fifth pastor. He served in Ogden for two and a half years and left for a call to Arcadia, CA, in January of 1975.

On April 26, 1976, Rev. Garland E. Gotoski, from Manchester, MS, was called. He began his eight (8) years ministry at Ascension on July 1, 1976. Rev. Gotoski helped the congregation develop and firmly establish itself in Christian ministry in northern Utah. With God's help the congregation began to flourish and its membership grew.

Pastor Gotoski was a man of "many talents." For example, during Lenten Services in 1977, Pastor Gotoski portrayed five (5) men who played major roles in the trial and crucifixion of Jesus. Each man was portrayed in authentic costume with appropriate settings.

In July of 1977, Ascension held its first Outdoor Worship Service. This was coupled with a Camporee that was held at Monte Cristo, UT.

During the period from 1978 to 1980, several cosmetic changes at Ascension:

- New Chancel furniture was donated by the Henderson family in memory of their son Samuel Eli.
- A storage and a Youth Room was added to the church building.
- A new church organ was given by an anonymous donor.
- Excess land was sold to Mountain Church of God.
- The congregation held a successful fund-raising event that allowed for new carpet in the Sanctuary and new pews to be installed in the Sanctus.

On April 14, 1981, a United Stated flag was flown over the Capitol Building in Washington D.C. This flag was flown in memory of Samuel B. Austin, a member of Ascension.

Ascension's first Lutheran Lay Renewal Weekend was held on September 17 and 18, 1982. Will L. Helms was general chairman of this faith-building celebration.

Pastor Gotoski retired from the ministry on September 4, 1984. He planned to settle on a cattle ranch in Oklahoma, as soon as his wife, Frieda, was in better health.

Ascension Lutheran Church was Debt-Free in September 1984. This was a landmark for the church.

Rev. Steven Wigdahl, who graduated from Luther Northwestern Theological Seminary, was serving as an Assistant Pastor of Zion Lutheran Church in Salt Lake City when he was called on July 5, 1984, to be the pastor at Ascension. He was installed on September 9, 1984. Ascension Lutheran Church was still a small, but stable congregation. During his fifteen-year ministry, Ascension's membership grew significantly. Pastor Wigdahl brought his musical talents to enrich our lives. He sang and played the guitar.

The congregation was able to purchase more than five acres of land at 1105 North Washington Blvd. for the remarkable cost of \$36,000, with the property being in the heart of a very rapidly growing part of the greater Ogden community.

The year 1985 marked the Twenty-Fifth Anniversary of Ascension Lutheran Church. The Celebration Worship Service was held in the morning on September 15, 1985, and an Open House was held from 2-4 p.m. that afternoon. The Ascension Choir and Bell Choir were active during this period in the church's history.

During 1993 and 1994, Linda Pearson interned as an Associate in Ministry and then was called to serve as the Associate in Ministry at Ascension.

In 1995, a building program was led by congregational member, Bruce Engelby, in collaboration with the architectural firm of Sanders and Hermann. The gifted and inspired artistic elements of our Sanctuary were created by Ernst Schwidder of Seattle, WA. The result is the beautiful building that we worship in today. Ascension Lutheran Church held its first worship service in its new church building on Sunday, August 13, 1995.

In 1996, Jan Krakow was called as an Associate in Ministry at Ascension.

In 1998, members of the Long-Range and Goal Implementation Committee, led by Dale Ostley, went to the Lutheran Camp in Eden to begin the process of developing long-range plans for the church. This process resulted in Mission and Vision Statements being adopted by the congregation on May 3, 1998.

#### Mission Statement

We are a community of Christians, saved by grace through faith in Jesus Christ, who calls us to spread the Word, to love and to serve one another, and to share our journey of faith.

#### Vision Statement

With the help of God, all members will:

- build a thriving youth program for grades pre-K to 12,
- participate in worship and local/world ministry,
- be connected in some type of fellowship,
- build strong ecumenical ties with area churches, and
- foster the spiritual growth of one another.

In 2000, Ascension called the pastoral team of Rev. M. David Kiel and Rev. Renee Kiel to lead the next phase of our ministry. Their work began among us on July 17, 2000. Not long after their arrival, Ascension witnessed significant growth, welcoming several new visiting families to the congregation every week.

During that year, a windstorm caused \$69,000 in damage to the church building. David Borchert led the reconstruction team. This was also the first year that The Great GRACE Race 5K Run and 2-Mile Walk was held.

Under the Kiels' leadership, the church became an "active" place. There were backpacking trips, canoe trips, and other outdoor activities. All the groups, Men's, Youth, Quilters, ELCW, Choirs, Bell Choirs, etc. grew and made great contributions in the church and community.

In 2001, Ascension conducted a Capital Fund Appeal Campaign, "Building a Faith-Filled Legacy," led by Executive Director, Jack Hilden. The appeal raised funds to begin work on the Campus Master Plan. The congregation was able to complete Phase 1 of the Community Life Center. This included completion of the building shell, three finished classrooms with self-contained restrooms for Sunday School use, the pre-school classroom, the pre-school director's office, a public restroom facility, and an expanded church parking lot.

In September 2004, Ascension Lutheran Church opened a Christian pre-school welcoming pre-school aged children of all faith traditions and of no faith traditions. In its fourth year, there were four teachers and four aides serving sixty students. The pre-school had operated under the direction of Laura Fuller until the 2008-09 school year. Church member, Marilyn Roberts, donated the funds to provide the pre-school with a large playground and picnic area. She donated the funds in memory of her husband, Gene Roberts.

In February 2005, Ascension's Pastor Renee Kiel, a U.S. Army Reserve Chaplain, was activated for service in our nation's military. After preparing with a unit to be mobilized to Iraq, the orders were then changed. Pastor Renee was deployed, instead, to serve in Afghanistan under the "Operation Enduring Freedom" campaign. She served troops at many FOB's (forward operating bases) and at the Kandahar Air Field in the southern part of the country during the first part of her deployment. She served a Bagram Air Base, in the later part of her deployment and returned as active Pastor of Ascension in August 2006.

October 2005 found the people of Ascension entering a 2005 Capital Fund Appeal by Kairos & Associates. Executive Director, Layne Carver, led the campaign, entitled "The Center of Our Lives." The focus of this appeal was to center the congregation spiritually as people of God, reflecting upon scripture and prayer for personal and corporate study. The sixweek Bible Study, scripture and worship themes focused on what it meant to be chosen, saved, loved, called, gifted, and empowered children of God, keeping Christ as "The Center of Our Lives." This foundation and focus, with God's help, assisted the congregation as a community of individuals and as a gathered community of believers. A people seeking God's guidance in preparing to commit our gifts to our God, for His glory, through the mission and vision of ministry in His name, at Ascension.

During the summer of 2006, the congregation of Ascension Lutheran Church faced a time of deep loss and mourning when its beloved Director of Youth Ministry went missing in the Sawtooth Mountains of ID. Jon Francis, a 24-year-old from Stillwater, MN, and graduate of Augustana College, accepted the Youth Minister position. It was his first job out of college. While serving Ascension, he took a summer position as a counselor at Luther Heights Bible Camp (LHBC) near Ketchum, ID. On July 15, 2006, Jon, an expert hiker took advantage of a day off and left the Bible Camp for an intensive day of hiking and bouldering up Grand Mogul Mountain. He did not return from the outing. Many members of Ascension accompanied Jon's parents, family, and friends in Idaho and spent countless hours for two summers searching Grand Mogul. The search employed hundreds of volunteers along with professional search and rescue resources. On July 24, 2007, the family achieved the recovery of Jon's remains on the east face of the mountain. His death was determined to be the result of a fall. Jon was commended to God and laid to rest at home in Minnesota on October 9, 2007. The youth and community of Ascension are still grieving the loss of Jon. His position has not been filled.

Pastor David Kiel resigned his position as Senior Pastor of Ascension Lutheran Church, due to personal reasons in 2007. Since the call to the Kiels was co-terminus, the congregation voted to extend a solo call to Pastor Renee Kiel to serve the congregation.

The congregation of Ascension Lutheran Church raised funds independent of any capital campaign, with members and friends "buying squares of the gym floor" to complete the gymnasium. The gymnasium of the Community Life Center was dedicated between services in June 2008. This completed yet another phase of the Campus Master Plan of Ascension Lutheran Church.

Also, in 2008, Pastor Renee Kiel resigned her position as the congregation's solo pastor to answer a call for her and her husband from an ELCA Congregation in Iowa. Pastor Renee left the congregation on July 1, 2008. The church council held a special congregational meeting on July 12, 2008, to elect a Call Committee.

In August of 2009, Pastor Matt Muters was called to serve at Ascension Lutheran Church. He began structured Bible Studies. His musical talents gave great meaning to the service. He brought variety to the church services.

During Pastor Matt's time at Ascension, a focus on community could be seen in projects like the Christmas Bazaars, Garage Sales, the Cowboy Dinner, Community Food Drives, Baby Showers for the Ogden Pregnancy Care Center, Pancake Breakfasts, Youth Ski Trips, Trunk or Treat, Vacation Bible Schools and several other activities.

In 2010, the Mutual Ministry Team, Don Brown, Rhonda Joa, Layne Carver, Nancy Otto and Pastor Matt, met to review and revise the Mission Statement. The new Mission Statement,

Gathered and gifted to celebrate and share the love of Jesus.

This new Mission Statement was placed on the wall in the Narthex by Kelli Martin and Jeff Turner.

In April 2012, Drive-Through Prayer began. This ministry, led by Arliss Zimmerman, has reached many in the Ogden community. Each Saturday this group is involved in Bible Study and Prayer.

Later in November 2012, Elias Muters was born.

During Easter 2014, an Easter Vigil and Sunrise Service were held at the Outdoor Cross. The construction of this area was Ryan Reese's Eagle Scout project.

In November of 2014, Pastor Matt accepted a call to a church in Iowa to be closer to his dad, whose health was failing.

Pastor Eugene Zeller from Colorado became Ascension's Intentional Interim Pastor in January 2015.

Pastor Zeller guided the congregation through the Transition Process that was established by the Rocky Mountain Synod. The Transition Committee consisted of Lynn Benson, Eric Engelby, Judy Sherman, Babs Bezyack, Lillian Hughes, Mylitta Barrett, Bruce Maddox, Harold Brattland, John Williams, Sharen Kamp, and Pastor Gene Zeller. Church Historian were Sharen Kamp, Linda Allred, Paula Stuart, and Hazel Ann Linke. The historians established a visual timeline for Ascension's history that went around 3 walls in the Fellowship Hall. Each person added their name and date on the timeline for all the significant church events in their life. They were also able to fill in some important names and events. There were twenty=two (22) Team Meeting from Jan 22, 2015, Until November 2, 2015.

On March 22, 2015, we held a Meals and Memories event after church. The meal was a 1960 Sunday Dinner made by members of the congregation. The program was entitled, "This is Your Life – Ascension Lutheran Church." Our Core Values Statements were the following:

- \* Ascension Lutheran Church is a joyful liturgical and musical community nourished by Word and Sacrament. (Worship)
- \* Ascension Lutheran Church is a welcoming community gathered to share insights, wisdom, strengths, and encouragement. (Fellowship)
- \* Ascension Lutheran Church is a praying community conversing with God. (Prayer)
- \* Ascension Lutheran Church believes the Bible to be the written Word of God. (Bible)
- \* Ascension Lutheran Church believes the sermon is the proclaimed Word of God for this community at this time. (Sermon)

Our Mission Statement was reviewed, it was determined that we would leave it as is:

Gathered and gifted to celebrate and share the love of Jesus.

Our Vision Statement was established to strengthen our sense of being the church together.

Ascension Lutheran Church is a welcoming, Bible-centered, praying congregation striving to become a thriving, multi-generational community serving all.

We completed our Ministry Site Profile in April of 2016 and sent it to the Synod. In June of 2016, we updated it. At that time, the Call Committee led by Kelly Martin began their work. On September 13, 2016, a compensation package was prepared for Pastor Susan Swanson. Eric Engelby, Kelly Martin, Don Brown, and Sharen Kamp served on that committee. Pastor Swanson came to visit. However, she took a call in another state.

It was in 2016 that Family Promise was introduced to the Ascension congregation, and it was determined that this would be an important ministry for the church. On March 11, 2017, volunteer and coordinator training was held and our first family was scheduled to come in late April of 2017.

Once again, the Call Committee reviewed the candidates and selected Pr. Rick Brenton for our church. Kelly presented his name to the Council on February 9, 2017. He came to visit the congregation. In the April 4, 2027, it was decided to Call Pr. Rick Brenton. He was installed on July 16, 2017.

In May the Council voted to have the Noah's Ark Murial on the Nursery Wall. In June of 2017, Ascension said "Farewell" to Pastor Gene Zeller.

In August, the council began to prepare for the 500<sup>th</sup> Anniversary of the Reformation. We planted a tree in Wittenberg, Germany, and a reciprocal tree at Ascension on October 29, 2017. Brigitte and Buzz Schultz traveled to Germany to plant our tree. It was planted at Luther's House on November 12, 2017.

In July 2020, Pastor Rick Brenton left Ascension.

Again, the call Committee went to work. In the fall of 2020, the Council invited Pr Debra Jimenez to visit our congregation. Because COVID was active at that time, we met for Sunday Services in the parking lot of the church. A call was extended to Pastor Debra and she and her husband, James, arrived in December of 2020. In 2020, to keep close communication with the congregation, Melinda Tolle began making Seek and Find puzzles to send in a daily email to the congregation. A picture/graphic with special meaning for the congregation and coloring pages for both adults and children were included.

In January 2021, the ALC Constitution updates were approved by the congregation. The Fill-the-Freezer ministry began. The new classroom in the CLC was dedicated. Ascension's first youth member was invited to serve on the Council. Twins, Lauren, and Ryan Gorsline shared that responsibility. On April 25<sup>th</sup> we celebrated Compassion Sunday at Ascension. Vacation Bible School was June 21 to 25. All this and much more was accomplished while COVID continued to ravage our nation.

In January 2022, the congregation Approved a Change in Call for Pastor Debra to and Open Call.

New ministries that began in 2022 included a Million Little Things Program, a Capital Campaign to replace the stucco on the church exterior, a church cookbook, and Lenten Suppers and Book discussions.

On September 2023, Family Promise officially purchased the west portion of the property for a permanent building to best serve the homeless families they service. The purchase price was \$100,000.

December 2024 was a very busy month. A new roof was placed on the church the first week of the month. Secondly, on December 16, there was the ceremonial groundbreaking for the Family Promise building.

This written history is the work of many. As creator of the Annual Report, I would like to especially like to thank Sharen Kamp and Pastor Debra Jimenez for all their help assembling this history -Nicole Shane

There is a record book that dates to 1960 in the office that has names of pastors, congregational members, baptisms, deaths of members, confirmands, and weddings. It is hand-written by the current pastor. That record book will be 65 years old this year. Feel free to ask to see this record.

In the evenings and on the weekends, community sport teams make use of the gymnasium.

The main building housing our sanctuary, fellowship hall, and offices, is a place of weekly welcome for AA, Alanon, COSA, and Girl Scouts. In January, Life Line Screening will hold their second community screening event within these walls.

As this year comes to a close and we look forward to the promise of the year ahead, it is my earnest prayer that each of you know how much God loves you – just as you are! To our teens and young adults, I pray you know that in the middle of your trials, your identity questions, betrayals by friends, times of loneliness, finding your way and wondering just what life holds for you, the child in the manger is with you! #### **Council President Report**



- James Jimenez who serves as our Family Promise building liason,
- Kelly Martin who serves as our church Family Promise, and building use liason,
- Pastor Debra who serves as our spiritual guide
- Joanna Wolf our budget liason and
- Stefani Rhees who has learned so much on her first year of council.

Pastor Debra suggested that the property west of the parking lot be used by Family Promise. Family Promise purchased the property for \$100,000. We are again reminded that our church community is a ministry. The

groundbreaking was in December and the building could be completed as early as August 2025.

There have been many repairs completed on our building this year. Jim Craig has been diligently getting on the phone to find people who could complete these repairs and their bids to do so. He no longer serves on the council as property manager but with David Filanda has continued to work in this position. He deserves much thanks and love for so much in our church. Here are some of the projects that can now be said to be completed this year:



- two HVACs in the CLC were replaced,
- the stain glass window was repaired,
- the ALC's roof was striped down to OSB, new OSB added, the liner and shingles all replaced. Our insurance covered most of the costs.
- the Narthex roof was repaired,
- we have signed a new contract with KidzTown,

Ongoing projects include an ASL service, and the repair of the sacristy. As president I would like to have projection screens installed to replace the paper and printer costs. Edith suggested that our parking lot needs attention including removal of dead trees and branches. One last suggestion would be to repair/replace the parquet flooring due to raised pieces that are a tripping hazard.

As you can see, your council has been working hard for our congregation. We continue to seek volunteers for the treasury, finance, communion, music, bulletin, and parish notes ministries. It is all God's work, and many hands make light work. If you have not been asked to be in any of these ministries, please be bold and ask. We need you.

One of the most beautiful moments of church is the children. They continue to make us smile with their sincerity. Every Sunday they gather our loose change with zeal while Kamberlynne plays <u>Jesus Loves Me</u>. The children use this money to buy gifts from the ELCA Good Gifts Program. Who would not love to sit with these kiddos and pick out chicks, pigs, and goats?



As a church community, we are blessed by our spiritual leader, Pastor Debra. Her testimony and love for our Savior and the good works of the gospel are brought forward every sermon and in all her works as pastor and friend.

Finally, our campus is home base for four 12 Step groups, basketball teams, and Girl Scout troops. This all acts as an outreach to better serve our community to support our Vision Statement:

Annual Congregation Meeting

Feb 4, 2024

Called to order at 10:58am by Kelly Martin

Opening Prayer by Pastor Debra

Annual reports given out along with Church Directory

- Election of new Council Members. 1<sup>π</sup> we thank Jim Craig and Mylitta Barrett for their time on council. Edith Cryts took over for Connie Larson's position last year and has agreed to continue serving on the council. David Filanda and Stefani Rhees have agreed to be on council starting this year. Motion to accept new council members was made by Nancy Otto and 2<sup>nd</sup> by Patti Hall.
- 2) Election of Nominating Committee Members. Jim Craig will be on committee because leaving council members are required to be. Since Mylitta left the state we need 2 volunteers. Babbs and Renee Hart volunteered. Motion to accept nominating committee members was made by Edith and 2<sup>nd</sup> by Stefani.
- 3) Election of Rocky Mountain Synod Assembly Attendees, scheduled for April 25-27<sup>th</sup> in Colorado. Patti and Stefani volunteered with a motion to accept by Cindy Day and 2<sup>nd</sup> by Dorothy Harmon.
- 2024 Budget Motion to accept Jim C and 2<sup>nd</sup> by Cindy.
  - a. Discussion: Eric Engelby asked about the line "Business License" under Admin expenses. Weber county requires businesses to pay a license. It has been \$25 and expected to go up this year so that is the reason for the \$70 amount for 2024. Eric also asked about the "Security" line under Building, grounds & utilities. The broken special glass that cost \$3000 to replace caused us to buy a ring doorbell and some outside cameras to help with outside security. Other expenses were related to the fire sensors that were not working.
  - Kelly talked about the setting up of an emergency fund by putting in \$1000 a month to help cover expenses toward the buildings that are not a normal funded item.
  - c. Pat R. talked about the not balanced budget mentioning that we have pledges of \$132,000, about \$38,000 unpledged expected. We also have gotten around \$8500 from the Christmas Bazaar and can expect about \$2000+ from garage sale this year.
  - d. Renee asked about the "Pineview Water" also under the building expenses group. the 2023 amount was budgeted at \$600 but we spent \$1200 due to Pineview changing their due date so we ended up having to pay twice in 2023.
  - e. Motion to accept after discussion made by Patti H and 2nd by Jim C.
- 5) Vote to pay for a new HVAC system in the CLC, Kidztown area. The HVAC unit went out in January. It was an old enough unit that it was not worth trying to do a temporary repair. The council decided that it needed to be replaced. Susie, the CEO of Kidztown, told us they could not wait to replace the unit until after this meeting so it was decided that they would pay for it then give us the invoice for it. Headstart agreed to pay \$3500 of the approx. \$40000 bill. So the church will pay the remaining \$36,000 to Kidztown. Motion to pay the balance made by Nancy O and 2<sup>nd</sup> by Eric E.
- 6) Family Promise Construction Kelly said there was some trouble with some paperwork to be able to sell the land in the back to Family Promise. She said Pastor Debra will take the paperwork to the Synod Assembly to see if they could help. The plan is to sell Family Promise the land from that parcel for \$100,000 which is the approximate value of the land.
- 7) Open questions Comments
  - Sharen announced that the new Church directory is available and was handed out to members who attended this meeting.
  - Pastor Debra told us that Melinda Tolle donated some items, a griddle and pancake mix, crockpot, popcorn cooker and a few other things.
  - c. Nancy wanted to recognize Kelly for all her hard work and dedication to the church as the church president the last 3 years.

#### **Audit Committee Annual Report 2024**

The current Committee consists of three members, Linda Corey, Carol Jordan and Paula Del Carlo. Dorothy Harman resigned her position as Chairperson and assisted with the transition at January's quarterly meeting. The Committee is also supported by the Treasurer and Financial Secretary who prepare records and answer questions during the audit.

The Committee is required to meet yearly but we choose to meet quarterly. The last quarter of 2023 was audited in January 2024. The remaining quarters were audited in April, August and October 2024.



#### 2024 Annual Capital Campaign Report

During 2023, we paid off the final contractor expenses associated with Capital Campaign #1 to repair the southeast block window and stucco on the church building and have \$18,059.64 remaining which has been put towards "All Things NEW Again" #2. Phase 2 was slated to remove and replace shingles on the church roof and replace-as-needed Oriented Strand Board (OSB) plywood to correct the bowing in the roof plane. Council decided to create Phase 2, but would not solicit donations for the work as funds were eventually on-hand to complete the project.

An ALC church member donated an additional \$9093.68 making a total of \$27,153.32 available to complete the roof project.

During the fall of 2024, through the efforts of James Jimenez, Jim Craig, and Infinity Roofing & Siding, our State Farm Insurance policy had agreed to replace the shingles on the church roof due to wind/storm damage. Ascension received \$24,587.39 in insurance money to replace the shingles. The church council decided to add additional work to that effort and agreed to cover the cost of new OSB plywood and repair the portico roof over our church main entrance. That work was completed just before Christmas Eve. After the rain and snow during the last part of December, there has been no sign of leakage on the interior of the building. PRAISE THE LORD!!

Thank you to everyone for your generosity and support!! And a big thank you to James Jimenez and Jim Craig who provided the oversight for those roofing projects.




#### **Care Bear/Card Ministry**

### Family Promise of Ogden (FPO)

Ascension hosted families four weeks during 2024 We hosted families 11-18 February, 7-14 April, 3-11 Augus, and 8-15 December.

Thank you so much to everyone that volunteers as part of this ministry. We have a faithful group of people that come together every host week so that the families we are hosting are well cared for. In addition to our own congregation, we are blessed to have members from Elim, Our Saviors', and St. Paul Lutheran churches that faithfully provide meals, and hosting for our families.

In addition to our volunteer weeks. Ascension continues to participate in the fund raising done for FPOO. This year Ascension again hosted two tables at the Rise & Shine Breakfast. Together with the other supporters of FP, the fund raiser made more than \$100,000 that will be used to continue to provide ongoing services for the organization.



This year we completed the sale of the back portion of our property to Family Promise. On December 16, members of the community gathered for the Groundbreaking Ceremony for the new building that will serve as both the Day Center and the overnight housing for Family Promise. The estimated completion date for the building is August 2024

## **Family Promise of Ogden Building**

By way of history, Family Promise of Ogden, with Ascension representation by Kelly Martin, had long sought a building to convert or land on which to build a facility for administration of the program and temporary housing of homeless families. Despite years of fund raising and trying to identify such a property by Nolan Karras and others, no suitable opportunity had been identified.

Approximately 3 years ago, I was accepted onto the Family Promise board and shared this issue with Pastor Debra. As I understand it, as she was

taking a walk around the Ascension parking lot, viewing our property and it occurred to her that Ascension had more property than needed. She discussed this with Kelly Martin who supported approaching Nolan Karras at Family Promise to propose use of part of our property to build the Family Promise facility. Pastor Debra contacted Nolan Karras, walked the property and determined that this could be possible. A price of \$100,000.00 was established for the property by Kelly Martin and agreed to Family Promise, contingent upon obtaining all necessary approvals.

What followed was extensive work with Harrisville City Manager, Jenny Knight, who was convinced to support the project. Nolan and I attended a meeting with Harrisville to ensure that the process would move forward. Jenny Knight was extremely helpful and assigned the City's consultant, Jim Flint to work with us on establishing the suitability of the land and establishing what steps would need to be taken to make this work. In the meantime, Nolan also sought financial support from many sources to ensure Family Promise could build a 5,000 plus square foot facility.

Nolan and Flint worked closely together to assure the proper steps were taken. Nolan and I also met Sean Wilkinson at Weber County Development to ensure we were compliant on the County level. (It turns out that

he and his family are Family Promise volunteers, and he was totally supportive – God was running interference for us)!

At the same time, Nolan began working with State Sen. Gregg Buxton to gain funding support by the State of Utah. I was working with State Sen. John Johnson from Harrisville fo the same. With their and other support in the Senate, Family Promise was able to secure the funds necessary to fully fund the project. Agreement was reached for Ascension to provide access and parking for the facility.

Worth noting is that KidzTown was notified of the proposed project and was not initially supportive of it. A meeting was arranged between KidzTown ownership/management, Family Promise Executive Director, Raquel DaSilva, myself, Pastor Debra, and I think Kelly to see what the program has accomplished for homeless families, and they became avid supporters, even offering to provide playground equipment to Family Promise when the facility is completed.

Too many details large and small to go into (including essential Water Shares) but suffice it to say that the \$100,000.00 was paid by Family Promise to Ascension and will be applied to various projects needed for the remaining church property.

A ground-breaking ceremony was held on December 16 with attendance overflowing Ascension's Fellowship Area. It was announced at groundbreaking that a contractor has been identified, pending contract signature and target date for completion is August 2025. Thanks were given to all involved in this project, including God, for doing some fine work in front of and behind the scenes.

# KidzTown Report 2024

As the church council liaison to KidzTown, I meet up with key adults there to encourage open communication. The following is a summary of what transpired with the monthly meetings.

The dumpster is of a big concern due to the amount of garbage being put in by the community. The solution has been to find a way to use locks on the bin. There is an ongoing mystery of why KidzTown has their furniture and toys being moved. We asked them to get access to their cameras to find out who is doing the moving. Repairs are needed: cooling, landscaping, men's bathroom fan, kitchen oven, locks on doors that are difficult to use, gymnasium ceiling tiles falling and more. I would like to commend Jim Craig on his constant willingness to stay on top of these repairs as they come to light. He, and KidzTown liaison Rodney, are busy keeping up on all this maintenance so that the children are safe and comfortable.

This last September I was informed that KidzTown decided to split into two separate businesses. Our KidzTown along with four other facilities will be run by Suzie. She is quite aware that her facilities are not as new and eye-catching as the other group now called Awesome Kids. She requested that we address lawn care, dead tree removal, grass growing in the asphalt in order for this facility to thrive. We let her know that our volunteers at church will do what they can, when they can. If the repair is more costly, there is a long protocol that needs to be followed for our congregation to decide on how to move forward.

Suzie and her staff would like to thank us for our ongoing support. They loved the GWOH bread and jam gifts in September. They enjoyed the Trunk-or-Treat in October.

Finally, I sat in a meeting with some members of our council, Rodney, Shae, and Suzie to meet and greet each other so we could begin to work with each other as problem solvers. We discussed sprinklers, snow plowing, and other grounds keeping maintenance. Pastor explained my role as liaison to KidzTown and we all exchanged phone numbers.

# **Pastor's Discretionary Fund**

### **Property Management**

Last year was another eventful year for the Ascension church buildings. In early January, the furnace for the southwest side of the CLC failed. We had Mountain Home install a new HVAC unit on January 16th. The installation had issues and took three days, but Kidz Town had heat again. During the spring semi-annual check of all the ALC and CLC HVAC units, it was found that the air conditioner for the Northeast side of the CLC was broken beyond repair. That unit was replaced on June 27th.

The last significant event of Ascension Was the replacement of the ALC roof. We had structural issues with the sanctuary roof and had been working to fund fixing that. Some shingles had blown off during one of the Spring windstorms. Infinity Roofing contacted us and indicated they specialized in filing claims with insurance companies. We signed a contract with them to file these claims, and they got insurance to pay most of the costs of replacing the roof for the whole building. Thank you, James, for doing most of the work with Infinity Roofing during the insurance claims process.

The roof was finally installed in December. There were a few issues with the installation process, but Pete Gallego of Infinity Roofing responded quickly and fixed every problem to our satisfaction. We

now have a great-looking new roof on the whole building.








- All Saints Sunday candle-lighting remembrance of the saints who have entered the Church Triumphant.


#### **WELCA**
