

Surging Covid Cases from the Delta Variant

Hospital leaders in Utah renewed their pleas for people to get vaccinated and to continue observing safe practices as the state experiences another surge in new COVID-19 cases from the faster-spreading delta variant. Utah has averaged about 386 confirmed cases per day over the last week, nearly double the case rate the state was experiencing at its lowest point in early June. On Thursday, the state recorded 668 new cases.

The number of Covid cases and the test positivity rate in Weber County have increased recently and are very high. An average of 41 cases per day were reported in Weber County, a 60 percent increase from the average two weeks ago. Over 1073 positive cases were reported in Weber County for the month of June and 301 since the 1st of July.
